*****IMMUNIZATIONS NEEDED FOR 7TH GRADE BEFORE THE FIRST DAY OF SCHOOL AUGUST 2021*****

Your child is required to have a TDAP (Tetanus) vaccine, Meningococcal vaccine, and a second Varicella vaccine prior to school starting in August 2021.

The State of Texas requires that every 7th - 12th grade student enrolled in Texas Schools have these immunizations prior to school starting in August. Seventh grade students that have not received these immunizations will not be able to attend school.

Most students that have been enrolled in Texas Schools have already had the second Varicella vaccine.

CALL NOW to make an appointment with your child's doctor to get the required immunizations before the busy back to school rush. If your child does not have health insurance you can get the vaccines at the Grayson County Health Department. At this time, immunizations at the health department are by appointment only and cost \$20 (cash only). Please call 903-893-0131 ext. 1235 or 1237 as soon as possible to get your appointment scheduled as spaces will fill up quickly.
